The European Approach for Quality Assurance of Joint Programmes



Definitions in the European Approach

Joint programme:

An integrated curriculum coordinated and offered by different HEIs from EHEA countries, and leading to a joint or a double/multiple degree.

Joint degree:

A single degree, attested by a single document, awarded by HEIs offering the JP, and nationally acknowledged as the recognised award of the JP.

Double / multiple degrees:

Separate degrees awarded by HEIs offering the JP, attesting the successful completion of this JP.



The European Approach: what is it?

- One single programme accreditation, recognised in all EHEA countries involved
- 2. By a QA agency on the list of EQAR-registered agencies
- 3. This agency uses the agreed standards and procedures
- 4. The accreditation decision is to be accepted & recognised in all EHEA countries where the JP is offered
- 5. Countries may **not** apply any additional national criteria

Formal agreement needed on:



- The degree(s)
- Partner coordination and responsibilities
- Admission and selection procedures
- Student and staff mobility
- Examination, recognition of credits, degree awarding procedures





In practice:

- Not yet much used
- Not all countries have adapted their legislation



Additional national criteria problematic

(Source: ECA's JOQAR project)

Too many <u>national criteria and</u> <u>national requirements in external</u> QA/accreditation of JPs

- Sometimes not about quality
- Not suited for joint programmes
- Contradict each other

Very long list of examples:

- The assessment report (expert report) is required to be in the national language;
- National QA agencies not always allowed to coordinate an international procedure / undertake a site visit abroad;
- Master thesis: "max. 30 ECTS credits" vs. "at least 35% of the total nr of credits";
- Very detailed, national staff requirements
- ...

- International Peer Learning Activity (Oct 2017):
 - to identify obstacles & formulate action points
 - urging ministries to change legislation
- Dutch education ministry and NVAO are strong supporters of the European Approach

Possibilities JP accreditation in the Netherlands

Existing programme to a Joint Programme

- Regular programme accreditation (DD / MD)
- Regular accreditation + Protocol JD accreditation (JD)
 OR:
- European Approach (DD / MD)
- European Approach + Protocol JD (JD)

New Joint Programme

- TNO (DD / MD)
- TNO + Protocol JD (JD)

OR:

- TNO + European Approach (DD / MD)
- TNO + European Approach + Protocol JD (JD)



Dutch Protocol JD accreditation

- 1. Within existing accreditation, you may change up to 40% of your programme, without submitting a TNO.
- 2. This 40% may be an added foreign track (JP)
- 3. Criteria:
 - The core of the programme remains the same
 - Partners legally recognised in their own country
 - JD between HBO and WO possible as long as the JP is at HBO / WO level
 - The jointness of the JP is assessed.
 - Substantial Dutch participation required



New Legislation Joint Programmes



New Dutch legislation - joint programmes

- 1. Broader definition 'joint programme': from JD to DD/MD
- 2. Partner agreement: curriculum content and division, degree allocation, student registration, tuition fees

3. Student registration:

Dutch HEIs allowed to require a student to register at the Dutch institution for the full JP duration

4. Tuition fees:

Dutch HEIs allowed to set tuition fees lower than the regular legal fee (to € 0). Consequences for funding!



Consequences for government funding

If a JP student is registered at a lower tuition fee (than the regular fee), the institution receives:

- 1. no registration funds (inschrijvingsbekostiging)
- 2. diploma funds (diplomabekostiging)



Current law: the 25% regulation

In the case of a **4-year** DD bachelor programme offered with a foreign institution,

the student needs to be registered at the Dutch institution for **at least 1 year**.
